COVID-19 Weekly Newsletter For Parents, Carers and Students 29 January 2021

Introduction/Headlines

A warm welcome to our second newsletter. Please note that we may repeat one or two key bits of information each week that are important or need action.

Over the last week there has been much speculation in the press about when schools will fully open again and it is not helpful to students, parents, carers or College staff. In fact, it often creates frustration and anxiety. It has been rare, since the start of the pandemic, that schools have been provided with much clarity or advance notice. We are however, pleased that we now have at least some certainty about what will be happening in the coming weeks (although we are, of course, disappointed that we won't have everyone back in College for a little while yet). The key announcements by the Prime Minister on Wednesday in Parliament were as follows:

- The earliest schools might 'begin to re-open' will be Monday 8 March, which is the start of the third school week after the half-term holiday.
- There will be a plan/review set out on Monday 22 February (the first day after the half-term holiday), with further updates.
- Schools will get two weeks' notice from when the decision is made for schools to re-open.

At present, this means that we have at least four more school weeks of students learning at home under the current arrangements. I know that this will be bitterly disappointing for many families and the children, but I hope that it provides some hope that there might be an end in sight, at least in terms of getting the children back into school.

We also received a clarification from the Department for Education (DfE) this week that schools would not be asked to open over half-term for children of critical workers as was the case in the first lock-down. However, the College is required to carry out the track and trace process over half term, so if your child is attending College, shows symptoms before we break up and then subsequently receives a positive Covid-19 test result over half term, please let us know by emailing absence@helston.cornwall.sch.uk.

One of the things that keeps me going through these times is seeing a sample of the excellent work that students have produced. Please encourage your child to share their best work with me via the Year Group Google Classrooms; this gives me an opportunity to engage with them directly.

Safeguarding/Wellbeing

It is important to remember that being able to express yourself is not about being the best at something or putting on a performance for others. It is about finding a way to show who you are, how you feel and how you see the world, through an activity that is enjoyable and can help you feel good about yourself.

National Charity Place2Be has created activities and resources to help children (and adults) explore further. There are also many resources on the Children's Mental Health Week website that you can use at home; including activity ideas and tips for parents and carers.

As I mentioned last week, please get in touch with the College if you have any concerns or would like some support or advice and we will do what we can to help.

This week we have added student testing to the staff testing for Covid using the lateral flow tests and it has gone really well. A big thank you to the students (and staff) who have taken part so far - they have all been great. Everything we can do to protect each other and ourselves at this time is important.

A reminder that, in line with the latest guidance, we are testing to identify asymptomatic cases as part of our measures to keep the College environment as safe as possible; we are not using daily tests as an alternative to isolating for close contacts of positive cases.

There are still a significant number of nil returns for permission to test. To clarify, on the form you can tell us if you give consent for your child to be tested using the lateral flow devices, or to inform us that you do not want them to be tested. Inviting parents as guardians to Google Classrooms - if you would like to see summaries of the work set and whether it has been handed in, the College can invite you as a guardian to your son or daughter's Google Classroom. We will then arrange for an invitation to be sent from Google Classroom to enable you to sign up. If you do not receive an invitation within a couple of days of your request, please check your spam folder. Otherwise, contact the College again and request that we send another invitation.

The College is updating its privacy policy to reflect some of the changes arising from online education. The change refers to the use of Google Meets. In some situations, the teacher can record a Google Meet, this is for safeguarding reasons and where the teacher feels it would be beneficial for students to watch recorded sections to help with their learning. These recordings will be stored until the end of the academic year.



Post 16 and Year 11

Starting on 4 February, the Post 16 team will be aiming to interview all the Year 11 students remotely. This is a chance to discuss their ambitions, aspirations and their Post 16 Options. 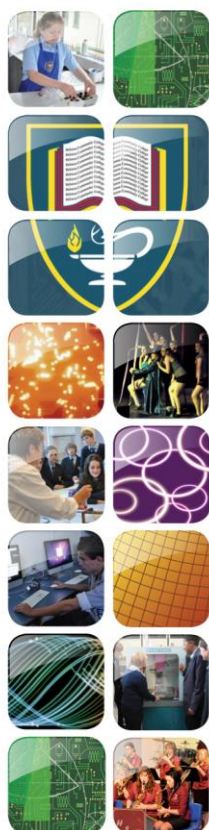
Year 11 - remote interviews to discuss Post 16 Options will take place from Thursday 4 February until Friday 12 February 2021.

Keyworker Provision Bookings

We now have over 10% of our students attending in-school provision, which is double the national average for secondary schools, and we are approaching the maximum capacity that we can accommodate in College. It is important to note that this provision may be removed from students who fail to maintain high standards of behaviour. We need to keep everyone safe and poor behaviour is unacceptable.

Complex rotas are in place to allow staff to fulfil their teaching commitments, both for students engaged in remote learning and students accessing the in-school provision. It is therefore crucial that we are aware of the numbers attending, as there is a significant amount of advance planning required.

A link to the booking form by email and/or text each Wednesday will be sent to parents and carers of keyworkers and vulnerable students who have informed us that they require on-site



provision at College. Please could we ask that you complete the form by **1pm each Friday**, to allow us to organise our staffing for the following week.

Students attending in-school provision need to bring their own earphones with them so that they can listen to recorded lessons (lightning connector and bluetooth earphones do not work).
